WAIVER:

In consideration of being allowed to participate in the **2020 PTEF Family Fit Fest**, the undersigned:

Acknowledge and fully understand that each participant will be engaging in activities that involve risk of serious injury, including permanent disability and death, and severe social and economic losses which might result not only from their own actions, inactions or negligence but the actions, inactions or negligence of others, the rules of play, or the condition of the premises or of any equipment used. Further, that there may be other risks not known to us or not reasonably foreseeable at this time. Assume all the foregoing risks and accept personal responsibility for the damages following such injury, permanent disability or death.

- Release, waive, discharge and covenant not to sue the volunteers and organizers of this event, if applicable, owners and leasers of premises used to conduct the event, all of which are hereinafter referred to as "releases", from any and all liability to each of the under signed, his or her next of kin for any and all claims, demands, losses or damages on account of injury, including death or damage to property, caused or alleged to be caused in whole or in part by the negligence of the releasee or otherwise.

I attest and verify that I have full knowledge of the risks involved in this event, and I am physically fit and sufficiently trained to participate. Knowing these facts, and in consideration of your accepting my entry, I for myself, my heirs, executors, administrators, or anyone else who might claim on my behalf, (a) covenant not to sue and waive, release, and discharge the above parties, **City of Indianapolis, Perry Township Education Foundation, Perry Township Schools, race officials, workers or volunteers, their representatives, successors, or assigns** from ANY AND ALL claims or liability, whether foreseen or unforeseen, including for death, personal injury or property damage, arising out of, or in the course of, my participation in this event, (b) indemnify and hold harmless the entities or persons mentioned in this paragraph from any and all liabilities or claims made by other individuals or entities as a result of any of my actions during this event, (c) assign hereby to the above parties any claim I have or might have, in contract or in tort in any way, shape, form or fashion arising out of its action, the actions of other participants or anyone who comes in contact with participants, which assignment is intended to be a full and complete assignment of any claim I have against the entities and persons mentioned in this paragraph whether directly or through third parties and (d) release the above parties from any and all claims based upon or arising out of the use, reproduction, distribution, display or performance of all or any part of any photographs or recordings or any derivative thereof, including any claim of invasion of privacy or right of publicity.
